

## Appeal Dates & Information

If you have not been offered a place at **Hackney New School**, the law entitles you to appeal against that decision to an Independent Appeal Panel. This panel is completely independent of the school and the Local Authority. The appeals are held at the school.

If you wish to appeal, please use [this link](#) to complete your appeal online. Please do NOT use ANY other appeal form or send your form to your local authority. It is suggested that you download the explanatory booklet about appeals which you should read before you complete the appeal form. [Booklet Link](#)

You should include any evidence or supporting material with your appeal form and you MUST give the grounds for your appeal at the time you lodge your appeal form. Your appeal form will not be accepted unless you state the grounds for your appeal. You may appeal for more than one school.

Please note that the online form will ask you to download two utility bills dated in the last THREE months. If you do not have access to a scanner, please take two photographs with a mobile phone and upload the photographic files.

Depending on the situation at the time, your appeal could be heard online instead of a face to face meeting at the school. Full details will be sent to you with your invitation to the hearing.

### The timetable for appeals is as follows: -

Last day for lodging appeal forms for a place in year 7 to start in <b>September 2021</b>	4pm on <b>Tuesday 30 March 2021</b> to guarantee that your appeal will be heard in the first tranche of appeals. Appeals lodged later may not be heard until the second tranche which could be in <b>September 2021</b> . You <b>MUST</b> state the reasons for your appeal and supply any documentary evidence at this stage.
The stage 1 part of the hearing (with other parents present) will take place on	<b>Wednesday 16 June and Thursday 17 June 2021</b>
Part 2, the individual private hearings will take place on	<b>Wednesday 16 June and Thursday 17 June 2021</b> (depending on the number of appeals)
Invitation letter giving details about your hearing will be sent by the Clerk to the Independent Appeal Panel	At least 10 school days before the stage 1 hearing.
Any <b>additional</b> supporting evidence	<b>Wednesday 9 June 2021</b> . You are advised that additional paperwork received on the day of the appeal hearing will <b>not</b> be taken into account. Please provide the Clerk with FIVE copies of any <b>additional</b> evidence. All such evidence to be submitted in A4 format and NOT bound, but may be stapled on the top left hand corner. Paperwork submitted with your appeal form does not need to include 5 copies. These should be sent to PO BOX 367, Cuffley, Herts, EN6 4XZ.
Letter from the Clerk informing you of the decision of the independent appeal panel	Due to the high number of appeals held at this time, this may not be sent until up to 2 weeks after the last hearing for the school.

### Timetable for appeals for mid-term applications is as follows:

Last day for lodging appeal forms following a refusal for a place mid-term.	20 school days upon receipt of your letter of refusal. You <b>MUST</b> state the reasons for your appeal and supply documentary evidence at this stage.

### Timetable for appeals for the 6<sup>th</sup> form is as follows

Last day for Lodging appeals	<p>4pm on <b>Wednesday 2 September 2021</b> to guarantee that your appeal will be heard within the first weeks of September. You <b><u>MUST</u></b> state the reasons for your appeal on the online form and supply any documentary evidence at this stage e.g. a copy of your result sheet.</p> <p>Please note the timetable is very short to enable those appellants who win appeals to start as early into the school year as possible.</p> <p>Click <a href="#">here</a> for the 6<sup>th</sup> form appeal form</p>
